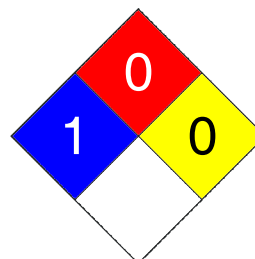

## 2. Hazards Identification

<b>Emergency overview</b>	<b>CAUTION</b> EYE IRRITANT. Skin irritation possible with prolonged exposure.
